Submission of papers:

Papers are called for in the following areas of Accounting and related disciplines:

- Accounting Education
- Accounting Education and Research
- Accounting History
- Auditing and Internal Auditing
- Corporate Governance
- Ethics
- Financial Accounting and International Accounting
- Financial Management
- Information Systems and Computer Auditing
- Management accounting
- Public Sector Accounting and Non-Profit Accounting
- Social and Environmental Accounting
- Taxation

Papers will be accepted and presented in two categories:

- **Refereed:** Manuscripts (research papers) of a sufficient academic standard are to be subjected to a referee process.
- **Non-refereed:** Manuscripts that will not be refereed. A manuscript can comprise a research paper, discussion of a particular topic, work in progress, comment on and/or discussion of an existing research paper, etc.

Abstracts must be submitted before **31 October 2016**, by email to 20161130saaa@gmail.com.

Refereed papers must be submitted before **31 October 2016** by email to 20161130saaa@gmail.com.

Papers for conference proceedings should be limited to 5000 – 8000 words including the reference list, with an abstract of between 150 and 250 words and 6-8 keywords.

- Paper heading should be Arial 14 with text Arial 12 using 1.5 spacing throughout the document. The headings in the paper for the different sub-sections such as abstract and introduction should be in caps and bold with any further headings only in bold.
- There should be no numbering for the headings.
- All references should use the Harvard reference method.
- 2.5cm margins should be used on all sides.
- Paper submissions must include a cover page and the paper. The cover page should be a *separate* file that includes the title of the paper as well as the category for submission (i.e. referred or non-referred), the name and surname of the authors and the respective university the authors are affiliated to, with contact details including the email address of the corresponding author(s). The paper should include the title of the paper, the abstract with and the details of the paper but should not have any reference to the authors.

The time for presentation shall be 20 minutes, plus an additional 5 minutes for questions.

BEST REFEREED PAPER PRIZE:

A prize would be awarded for the best refereed paper.
