Key Responsibilities:

- Review the receipt of supplier discounts and rebates in collaboration with the Accountant Creditors. Put plans in place to optimise rebates and discounts.

- Ensure sufficient cash provisions prior to the authorization of payments. Monitor and report cash flow liquidity risks to the Senior Manager / Head Financial Accounting
- Design, development and review Payroll policies, procedures and systems in on-going basis in line with relevant legislation, national standards and international best practice.
- Draft and submit recommended budget provisions on salary and benefit adjustments to the Senior Manager Financial Accounting
- Prepare and submit reports for reporting to various structures as required in accordance with the reporting schedule payroll reports.
