## THE HIGHER EDUCATION QUALIFICATIONS SUB-FRAMEWORK (HEQSF)

The National Qualifications Framework (NQF) is a system for the classification, registration and publication of articulated and quality assured national qualifications. The revised Higher Education Qualifications Sub-Framework (HEQSF), which was gazetted on 2 August 2013, forms part of this framework. The Faculty of Arts and Design is in the process of aligning all qualifications to the revised HEQSF.

#### WHAT DOES THIS MEAN?

Qualifications that are not aligned to the HEQSF will be phased out. New qualifications will replace the BTech and National Diploma. Some departments have opted to offer HEQSF-aligned Diploma qualifications, whilst others will offer Degrees.

The BTech, N Dip. and other qualifications that are not HEQSF-aligned will not be offered to first-time registering students from January 2020. Students who have registered for non-aligned qualifications before 31 December 2019 will need to complete that qualification before the final phase out date of that particular programme. Students who have already completed their National Diploma (NDip) and wish to register for the BTech have until 2019 to do so.

#### **HOW DOES THIS AFFECT ME?**

You need to ensure you complete your course before the final phase out date for the qualification you have registered for. As the BTech does not exist on the HEQSF, the Minister of Higher Education has gazetted 31 December 2019 as the final date for first-time entering students enrolling in academic programmes that are not aligned with the HEQSF. You will need to check the entry requirements and articulation pathways of your chosen course before applying.

#### WHAT EFFECT DOES THIS HAVE ON MY QUALIFICATIONS THAT WERE ON THE OLD NQF AND NOT ON THE HEQSF?

Your qualifications are still valid even though some of the current qualification types are not available on the HEQSF.

#### WHAT ARE MY OPTIONS?

For new (first-year, first-time) students registering, progression will be as follows: • Diploma → Advanced Diploma → Postgraduate Diploma → Master's Degree → PhD/ Doctorate

Or

• Bachelor's Degree→Honours Degree→Master's Degree→PhD/ Doctorate

Please note: This is the general route of progression on the HEQSF. For specific information on what qualifications will be offered by particular academic programmes, please consult the relevant department.

## GENERAL INFORMATION FINE ART

## **Facilities**

The programme is continually being upgraded and facilities are being improved. These include sculpture studios, providing for metal, clay, wood and resin work; painting studios; life drawing studios; printmaking workshops provide for etching, relief and serigraphic work and a fully equipped papermaking studio. Ceramics studios provide facilities for both studio ceramics and ceramic sculpture.

## The Programme's Aims

The programme aims to train and educate potential artists of high ability and provides a learning environment in which the creative abilities of students can be developed in the pursuit of the fundamental questions of art. Emphasis is placed on the practical development of skills and knowledge.

Furthermore, the Fine Art programme attempts to stimulate an interest and curiosity in Art Theory and to develop the critical, evaluative and analytical ability of each student.

## **Career Opportunities**

The field is diverse and challenging. On completion of the course the student is qualified to embark on a career as a professional artist working individually from a private studio or in collaboration with other artists to produce work of exhibition standard for galleries and collections of fine art throughout the country.

A recent survey has indicated that most of our past students have been gainfully employed as self-employed professional artists or within the educational or design fields as lecturers, technical art advisors, textile designers, gallery assistants, illustrators, advertising designers and visualisers.

## **Departmental Bursaries**

The department has a limited number of Bursaries. Preference will be given to senior (Dip III and B Tech) students who have a sound academic record. Students wishing to apply for financial assistance from the department should submit a written application to the Head of Department, giving certified details of their financial position and documented proof that they have applied for other bursaries and/or scholarships.

## PROGRAMME INFORMATION AND RULES

The new Diploma in Fine Art was offered for the first time in 2017. All first year students will register for the new qualification as the National Diploma is being phased out.

## I. Diploma in Fine Art, Dip (Fine Art), SAQA Registration number 72235, 360 Credits

The programme aims to train and educate potential artists of high ability and • provides a learning environment in which the creative abilities of students can be developed in the pursuit of the fundamental questions of art. Emphasis is placed on the practical development of skills and knowledge and on the students' application of their chosen major disciplines.

Furthermore, the Fine Art programme attempts to stimulate an interest and curiosity in Art Theory and to develop the critical, evaluative and analytical ability of each student.

- This is a three-year qualification, but can also be done via a 4 year extended curriculum.
- Our graduates are taught to become: •
  - I. Critical and creative thinkers who work independently and collaboratively
  - 2. Knowledgeable practitioners
  - 3. Effective communicators
  - 4. Culturally, environmentally and socially aware within a local and global context
  - 5. Active and reflective learners
- The field is diverse and challenging. On completion of the course the student is qualified to embark on a career as a professional artist working individually from a private studio or in collaboration with other artists to produce work of exhibition standard for galleries and collections of fine art throughout the country. Most of our past students have been gainfully employed as self-employed professional artists or within the educational or design fields as lecturers, technical art advisors, textile designers, gallery assistants, illustrators, advertising designers and visualisers.

## 2. Minimum Admission Requirements

• Admission requirements for this programme are spelled out in the General Handbook for Students under Rule G7.

## 3. Suitable Candidate Selection

Each learner requires a dedicated workspace in the various studios. Therefore, space is limited and the programme can only accept 30 first year students. The extended curriculum can take 10 additional students in the first year.

- Applications for the programme are made through the CAO via their website at www.cao.ac.za . The deadline for applications is the end of September.
- Prospective students are required to present a portfolio of specified art work and successfully complete a programme selection test, which consists of critiquing a selected art work and doing a still life drawing, and personal interview convened and assessed by a programme panel.
- Visual Arts or Design as a school subject is recommended, but not compulsory.
- The programme is limited to 30 places. Applicants are ranked and the top 30 are accepted. Ranking is done by judging the quality of the critique, and the still life drawing.
- Applicants that are ranked from 30 to 40 are enrolled for the extended curriculum. A maximum of 10 students can be registered for this option.

## 4. Registration

• Once candidates have been accepted, a deposit must be paid to secure their place. Registration takes place in January. Only candidates that have been accepted are allowed to register.

## 5. Programme Structure

- The Diploma in Fine Art is a full time qualification and can be done over three years, or via an extended curriculum, which takes four years.
- All subjects are compulsory and have to be passed to be awarded the qualification.

- 6. Promotion to a Higher Level/ Progression rules
- A student may only progress to a higher level once all the pre-requisite modules in the lower level are passed, as in G16

## Extended 4 Year Diploma

- a) In order to be permitted into year two (YEAR 2 on the Extended Curriculum Table above), students on the extended programme will be required to pass all subjects undertaken in year one (YEAR I on the Extended Curriculum Table above). (This rule is under consideration of the Senate Rules committee, for clarity refer to the department)
- b) Any student on year one of the extended programme who does not successfully complete the year will be deemed not to be making satisfactory progress and will not be able to register for the Extended Programme again.

## 3 Year Diploma

- a) A student must pass a subject at the required level in each year to qualify for promotion to the next level in that subject
- b) Students wishing to enter the 2nd and 3rd years of study are required to have passed all subjects of the previous level of study.

The following exceptions to the above rule (b) may be granted at the discretion of the Department:

- i. Students who fail Art Theory IB may register for Drawing IIA and ONE Major subject at 2nd year level whilst repeating Art Theory IB, provided that they have passed all the other subjects at the 1st level.
- ii. Students who fail Art Theory IIB may register for Drawing IIIA and ONE Major subject at 3rd year level whilst repeating Art Theory IIB, provided that they have passed all the other subjects at the 2nd level of study.

## 7. Unsatisfactory Academic Progress

- As per GI7
- 8. Assessment rules
- In all Art Theory modules, a cumulative assessment of a minimum of 4 assignments constitutes 100% of the semester mark.

- The final assignment in Art Theory 3B (Research Proposal) is externally moderated by a moderator appointed by the university.
- In all Professional Practice modules, a cumulative assessment of at least 3 assignments constitutes 100% of the final mark for the semester.
- In all practical subjects the first semester mark consists of the average of a minimum of four assessments.
- The second semester mark for practical subjects will consist of the average of a minimum of three assessments (40%), plus one portfolio assessment (60%).
- All final year modules will be moderated externally

## 9. General Education Modules

• General Education modules are embedded in the programme and are therefore compulsory.

## **10. General Department Rules**

- Attendance registers are taken for all classes, and are used to assist in determining a student's duly performed (DP) status. In order to receive a class mark at the end of each semester to allow a student to write the tests and submit a portfolio, a student is expected to attend all lectures, tutorials and practicals. Attendance at critiques and briefing sessions are compulsory.
- In the case of prolonged/repeated illness/absence students shall submit medical certificate or may be disqualified from the summative assessment if in the opinion of the Programme Committee (consisting of the HoD, Programme Coordinator and the lecturer concerned) they are no longer able to meet the minimum work requirements in any subject for which they are enrolled.

## Rules for Masters Programme Master of Arts in Fine Art, SAQA ID 72183 (96830), 120 Credits.

- An aim of the course is to educate artists in a number of disciplines for entry into the art and design market with a high level of technological, conceptual, communicative and creative skill. The Master of Art in Fine Art course provides a context in which this guided study may be consolidated and advanced.
- The course is structured to provide an integrated approach to theory and practice, although its emphasis is on practice-based research. The proposed theoretical argument should centre around, and be integrally related to, the research question explored in the practical work. The practice led and the academic theoretical research is a theoretical contextualization and critical analysis of an approved research topic, situated within the realm of contemporary art discourse.
- In addition, see Rules G24 and G26 in the Rule Book for Students, and the Postgraduate Handbook.

## 12. Appeals

To appeal against the application of any of these rules, refer to GI (8)

## NATIONAL DIPLOMA IN FINE ART NDFAR2 NB: THIS QUALIFICATION WILL BE PHASED OUT BY 2019

## AF2 ENTRANCE AND REGISTRATION REQUIREMENTS

National Senior Certificate or equivalent qualification as determined by the General Rules.

### Additional Requirements

Prospective students are required to present a portfolio of specified artwork and successfully complete a programme selection test and personal interview convened and assessed by a programme panel.

Visual Arts or Design as a school subject is recommended, but not compulsory.

## AF3 PORTFOLIO DONE DURING THE YEAR

In addition to the provisions of the General Rules the following shall apply:

- The practical work of the students will be assessed regularly. It will constitute 40% of the final practical mark and serve as an indicator of their progress during the year.
- (2) The final mark for practical subjects will consist of the regular assessments (40%) and the evaluation of a portfolio submission of work done during the year (60%).
- (3) Notwithstanding the provisions of the Copyright Act No. 8 of 1978 with regard to the protection of the right to ownership of original artwork by the artist, no practical work may be disposed of in any manner whatsoever until end-of-year assessment has been finalized.
- (4) Students are required to attend 80% of their lectures, tutorials and practical. Failure to do so may disqualify them from summative assessment in that subject, except in cases of illness, for which a valid medical certificate is supplied, or circumstances, which in the opinion of the Programme Committee were beyond the student's control.

In the case of prolonged/repeated illness/absence, students shall present medical certificate or may be disqualified from the summative assessment if in the opinion of the Programme Committee they are no longer able to meet the minimum work requirements in any subject for which they are enrolled.

## AF4 ASSESSMENT

In addition to the provisions of the General Rules the following shall apply:

- (1) The final mark in each Diploma, B.Tech and Master's Degree subject shall be subject to moderation by an external examiner nominated by the Institution.
- (2) Specific requirements for end-of-year portfolio submission shall be determined by the Programme Subject Committees (these consist of the Programme Coordinator and appointed subject specialist lecturers).

## AF5 PASS REQUIREMENTS

The following rules apply for promotion purposes and for the completion of diplomas in respect of full-time study:

## 3 Year Diploma

- (a) A student must pass a subject at the required level in each year to qualify for promotion to the next level in that subject
- (b) Students wishing to enter the 2nd and 3rd years of study are required to have passed all subjects of the previous level of study.

The following exceptions to the above rule (b) may be granted at the discretion of the Department:

- (i) Students who fail Art Theory I may register for Drawing II and ONE Major subject at 2nd year level whilst repeating Art Theory I, provided that they have passed all the other subjects at the 1st level.
- Students who fail Art Theory II may register for Drawing III and ONE Major subject at 3rd year level whilst repeating Art Theory II, provided that they have passed all the other subjects at the 2nd level of study.
- (c) A qualification must be completed within 5 years and a student is only allowed two years to complete each level. Failure to comply with this rule precludes re-registration in the Fine Art Programme.

## Appeals:

Students may apply with a motivation to the Head of Department in writing to be reconsidered for readmission. The Head of Department will make recommendation to the Faculty Board/EXCO/ TLC for a decision.

## BACHELOR OF TECHNOLOGY IN FINE ART BTFARI AF.HQI ENTRANCE AND REGISTRATION REQUIREMENTS

In addition to the provisions of Rule G23A the following rules shall apply:

- (1) The departmental selection panel, consisting of at least the Head of the Department of Fine Art and Jewellery Design and two members of staff, will evaluate the student's potential to pursue a higher programme of study at the required academic level, taking into account:
  - I An interview in which the student motivates for study at a higher level
  - 2 The student's results in Art Theory 3, and the Major Practical 3 subject in which they intend to specialize
  - 3 A written proposal in the B Tech format in which the student outlines their proposed area of study

## AF.HQ2 ASSESSMENT AND REPORT

The following rules shall apply:

## (I) **Practical Work**

- (a) The year mark will consist of six continuous assessments made by a panel of internal examiners. This will constitute 40% of the final course mark.
- (b) The portfolio shall take the form of an exhibition of work completed during the year with the accompanying programme of study. The portfolio (the report and the programme of study should be adequately linked and) shall be evaluated by a panel of examiners, which shall include an external examiner appointed by the Durban University of Technology. This will constitute 60% of the final course mark.
- (c) Only when the supervisor is satisfied with the quality of the student's work may the student submit work for final assessment.
- (d) The student may submit work for assessment only if he/she has satisfied the sub-minimum requirement of 40%.

## (2) **Theoretical Work**

The assessment shall take the form of a 100% course mark derived from a research project consisting of seminar papers, oral presentations and a written report.

## AF.HQ3 ATTENDANCE

 Full-time students are required to attend the Durban University of Technology for the normal working hours of at least 30 hours per week except where they are required to carry out research outside the Institution.

## MASTERS OF ARTS IN FINE ART MFFARI

## AF HQ4 ENTRANCE AND REGISTRATION REQUIREMENTS

In addition to the provisions of Rule G24 the following rules shall apply:

- The student shall appear personally before a selection panel consisting of at least the Head of the Department of Fine Art and Jewellery Design and the Programme coordinator.
- (2) The student must satisfy the selection panel that he/she possesses the potential to pursue a higher programme of study at the required academic level and should have obtained above average results in the prerequisite qualification to the intended programme of study.

## NATURE OF WORK

The traditional training for a jeweller's career was an apprenticeship at a recognised master jeweller's workshop.

Through the innovations of mass production, it became necessary to train people for all the aspects of the highly specialised production processes of the factories.

The University's instructional programme trains students in designing, manufacturing and marketing of jewellery, the basic principles for a successful career in the jewellery business.

On completion of the instructional programme graduates will have no difficulties in coping with the variety of manufacturing and designing functions, especially if they have obtained the Bachelor of Technology after four years' training, or at least 6 months of practical working experience after having obtained the Diploma or National Diploma.

## **PROGRAMME CONDITIONS**

A small jeweller's workshop has only a few staff members, who work very closely in a team. This needs all-round people with good social relationships, able to co-operate and work with total honesty in dealing with their very precious working materials. These jewellers design individual pieces of jewellery, manufacture the pieces and sell them to their customers. They are also responsible for the management of their business.

Jewellery factories need people specialised in different fields: designing, manufacturing, model-making, casting, setting and marketing of the products.

Some small jewellery shops sell jewellery on a retail basis. They employ people for selling and repairing jewellery, as well as for general managerial duties.

## PERSONAL QUALITIES REQUIRED

Creative imagination and artistic ability, but also practical skills of a high standard, are needed. Some technical aptitude is also recommended.

Patience, accuracy and attention to detail are a must for the student. A good all round educational background is an advantage.

Honesty is an essential quality in a jeweller.

## **OPPORTUNITIES**

Although limited vacancies exist, there are always good opportunities for properly trained, highly motivated and talented young people.

## **PROGRAMME INFORMATION AND RULES**

The Diploma in Jewellery Design and Manufacture was introduced in 2017. All new first year students will register for this programme. The National Diploma will be phased out by 2019. The following rules pertain to the Diploma. The rules for the National Diploma are spelled out from DJ2 onwards.

- 1. Diploma in Jewellery Design and Manufacture, Dip (Jewellery Design and Manufacture), SAQA ID number 100800, 360 Credits
- A qualifying learner will be competent in the production of creative jewellery using a variety of skills and materials.
- This is a three-year qualification, but can also be done via a 4 year extended curriculum.
- Our graduates are taught to become:
  - I. Critical and creative thinkers who work independently and collaboratively
  - 2. Knowledgeable practitioners
  - 3. Effective communicators
  - 4. Culturally, environmentally and socially aware within a local and global context
  - 5. Active and reflective learners
- This programme teaches students how to design, manufacture and market jewellery, the basic principles for a successful career in the jewellery business.
- After graduation an additional two years of training, in the form of an internship with a qualified goldsmith, is required for access to the Goldsmith Trade Test (Diamond Mounting).

## 2. Minimum Admission Requirements

• Admission requirements for this programme spelled out in the General Handbook for Students, Rules G7 and G21A (in the case of the National Diploma)

## 3. Suitable Candidate Selection

Each learner requires a dedicated workbench with a soldering torch and pendant motor. Therefore, studio space is limited and the programme can only accept 16 - 18 first year students. The extended curriculum can take 6 additional students in the first year.

- Applications for the programme are made through the CAO via their website at www.cao.ac.za . The deadline for applications is the end of September.
- Due to the creative nature of the programme it is important that applicants provide a portfolio of their own creative work as part of the selection test. Additionally, drawing and practical tests are carried out to assist with selection.
- Applicants are ranked and the top 16 18 (depending on space) are accepted. The rankings are based on the quality of the portfolio, the drawings and the practical tests.
- Using the rankings as a guideline, the next 6 applicants are enrolled for the extended curriculum. A maximum of 6 students can be registered for this option.

#### 4. Registration

• Once candidates have been accepted, a deposit must be paid to secure their place. Registration takes place in January. Only candidates that have been accepted, and that have met the Institutional and Departmental admission criteria, are allowed to register.

#### 5. Programme Structure

• The Diploma: Jewellery Design and Manufacture is a full time three-year qualification and can be done via an extended curriculum, which takes four years.

#### 6. Promotion to a Higher Level/ Progression rules

- A student may only progress to a higher level once all the pre-requisite modules in the lower level are passed, as in G16
  - 6.1 Students who fail Jewellery Design I (JDES102) must re-register for Jewellery Design I (JDES102) and may register for Jewellery Theory 2 (JTHY201) and Jewellery Drawing 2 (JDRG 202).
  - 6.2 Students who fail Jewellery Techniques 1 (JTEC 101) must re-register for Jewellery Techniques 1 (JTEC 101) and may register for Jewellery Theory 2 (JTHY201) and Jewellery Drawing 2 (JDRG 202).
  - 6.3 Students who fail Jewellery Drawing I (JDRG 102) must re-register for Jewellery Drawing I (JFRG 102) and may register for Jewellery Theory 2 (JTHY201).
  - 6.4 Students who fail Jewellery Theory I (JTHY 101) must re-register for Jewellery Theory I (JTHY 101) and may register for Jewellery Drawing 2(JDRG 202).
  - 6.5 Any student on year one of the Extended Programme who does not successfully complete the year will be deemed not to be making satisfactory progress and will not be able to register for the Extended Programme again. (This rule is under consideration by the Senate Rules committee, refer to the department for clarity)

#### 7. Unsatisfactory Academic Progress

#### 8. Assessment rules

- A cumulative assessment of at least 3 assignments and/or tests constitutes 100% of the semester mark.
- In practical modules (Jewellery Manufacture, Jewellery Design and Drawing), there are a minimum of 3 projects during the semester and a moderated portfolio display at the end of the semester. These will be used to compile a 100% course mark.

#### 9. General Education Modules

• General Education modules are embedded in the programme and are therefore compulsory., but there are a number of electives to choose from.

#### 10. General Department Rules

- Attendance registers are taken for all classes, and are used to assist in determining a student's performance. In order to receive a class mark at the end of each semester to allow a student to write the tests and submit a portfolio, a student is expected to attend all lectures, tutorials and practical. Attendance at critiques and briefing sessions are compulsory.
- Failure to submit assignments will result in a zero being awarded, and late submissions will be penalised.
- Only valid reasons, such as a doctor's note or a police affidavit will be accepted for Condonement, and only one Condonement per subject is allowed.
- Guidelines for student conduct in the workshop are detailed in the various study guides.

# NATIONAL DIPLOMA / DIPLOMA IN JEWELLERY DESIGN AND MANUFACTURE

#### DJ2 REGISTRATION

In addition to the General Rules pertaining to Registration, a student whose fees are being paid by an employer shall provide a letter of authority to this effect from such employer before registration.

#### DJ3 ENTRANCE REQUIREMENTS

In addition to the General Rules, the rule for admission to particular instructional programmes may determine specific entrance requirements.

#### DJ4 PRACTICAL WORK DONE DURING THE YEAR

Year marks shall be determined in accordance with the rules for each instructional programme.

Notwithstanding Rule G15, where a student fails a subject which he registered for after 1 January 1990 his year/semester mark is valid for one further consecutive main examination in that subject.

#### DJ5 PROMOTION TO HIGHER LEVEL

N.Dip. Programmes:

- I. As per GI6.
- 2. The final mark will comprise:
  - Theory subjects continual assessment Practical subjects — 40% year mark — 60% controlled project plus portfolio presentation. (See DJ.J4 and syllabus)

#### DJ6 PASS REQUIREMENTS

#### Year One (Extended Programme)

In order to be permitted into Year 2, students on the Extended Programme will be required to pass all subjects undertaken in Year 1 of the Extended Programme. [This excludes Cornerstone 101, which has to be repeated in year 2 (SP 3). This rule is under consideration of the Senate Rules committee, for clarity refer to the department.]

#### N Dip and B Tech Programmes:

In accordance with GI4, the 40% sub-minimum will also apply to practical examinations and portfolio presentations. Only one practical project may be condoned per year.

#### DJ7 SUPPLEMENTARY EXAMS

- 1. The provision of G16 will apply except in the case of a practical subject or portfolio submission where there can be no supplementary examination.
- 2. Supplementary theory examinations must be written and passed prior to enrolment for the next level.
- 3. Where a student fails a subject which he registered for after 1 January 1990 his year/semester mark is valid for one further consecutive main examination in that subject. In addition, where a student fails a subject and is granted a supplementary examination, his year/semester mark is valid for that supplementary examination.

# DJ8 ATTENDANCE REQUIREMENTS FOR NATIONAL DIPLOMA/DIPLOMA AND BACHELOR OF TECHNOLOGY

- Full-time students will attend at least 80% of both theory and practical lectures for the normal working hours five days per week, except where they are required to carry out research outside the DUT. Failure to do so can result in a zero being awarded for the project during such periods of non-attendance. Only a doctor's certificate will be deemed acceptable.
- 2. Part-time students will attend for half the normal lecture/studio hours as above.
- 3. Attendance at critiques and briefing sessions is compulsory. Nonattendance at a critique can result in a zero being awarded for that project. Students who fail to attend briefing sessions may be refused permission to complete the project.

# NATIONAL DIPLOMA IN JEWELLERY DESIGN AND MANUFACTURE

#### DJ.JI ENTRANCE REQUIREMENTS

National Senior Certificate or equivalent qualification as determined by the General Rules.

#### Additional Requirements

Prospective students are required to present a portfolio of specified art work and successfully complete a programme selection test and personal interview convened and assessed by a programme panel.

The NSC subjects Visual Arts, Design and Engineering, Graphics and Design are recommended but are not a pre-requisite.

The NSC rating code of 3 or higher is required for the subject English.

#### DJ.J2 DURATION OF STUDIES

A qualification must be completed within 5 years and students are only allowed 2 years to complete each level. Failure to comply with this rule will preclude the student from re-registration in the Department of Fine Art & Jewellery Design. Students wishing to appeal against this ruling should refer to Rule G1 (9) in the General Handbook.

#### DJ.J3 MARKING

In addition to the General Rule (G14), all assignment and project marks will be averaged except in cases of legitimate condonation of non-submission. Failure to submit an assignment on time will result in a zero being awarded which will be included when calculating the year mark.

#### DJ.J4 PRACTICAL WORK DONE DURING THE YEAR

In addition to requirements of the General Rules, the University has the right to retain selected items for the departmental collection.

For such items the department will compensate the materials value.

The Department has the right to retain all items made during classes for five years after a diploma has been obtained.

#### DJ.J5 EXAMINATIONS

#### **Extended Programme:**

The subjects will be assessed as 100% Course mark including a portfolio. Any student on Year One of the extended programme who does not successfully complete the year will be deemed not to be making satisfactory progress and will not be able to register for the Extended Programme again.
