4. DIPLOMA IN LANGUAGE PRACTICE: CODE (DILPRI) SAQA ID (109819)

3-year full-time, NQF Level 6 qualification, SAQA credits is 360

4.1 Purpose

A learner at this level will be able to effectively and independently combine theory and practice in the areas of translation and interpreting in order to accommodate the pragmatic needs of language and communication clients in both local and international contexts.

4.5 Programme information and rules – Diploma language practice

Placement assessments

Based on a variety of placement assessments, successful applicants for study towards a Diploma will be accepted into a three-year qualification.

Registration to Professional bodies or associations

The qualified person may be able to register with the South African Translators' Institute (SATI) or any other relevant body/association.

RULES

Attendance

- (i) A student is required to attend all lectures. Exceptions are given only in a case of illness for which a valid medical certificate is supplied specifying the nature and the duration of the illness, or a sworn affidavit, or circumstances which in the opinion of the department were beyond his/her control at the time.
- (ii) A student is required to attend all practicals and tutorials. Exceptions are given only in a case of illness for which a valid medical certificate is supplied specifying the nature and the duration of the illness, or a sworn affidavit, or circumstances which in the opinion of the department were beyond his/her control at the time, otherwise, a 100% attendance at all practicals and tutorials is required.

Year Mark

- (i) The year mark counts for 40% of the final result in modules assessed by final examination, except where otherwise indicated.
- (ii) The Examination counts for 60% of the final mark in modules assessed by final examination, except where otherwise indicated.
- (iii) The year mark of modules assessed through continuous assessment, is based on the assessment method of each module.
- (iv) Students are given sufficient opportunity to accumulate a year mark. The number of assessments in each modules as determined by the lecturer will be indicated to students.
- (v) A student must submit all tests and assignments for a module in order to obtain a course mark.

Selection criteria for this programme

Students who meet the minimum requirements will be selected based on the following:

- An entrance test (language proficiency) will be scheduled for shortlisted candidates. The required success rate is 60%.
- Interview in the first language.
- Interview in the second language.

The successful candidates are ranked according to the average mark (written test + interviews) and the target number of students are selected in order of performance. Priority is given to first-time applicants.

Further to the process, Admission Requirements (General Rule G7) applies.

Assessment Plan

There are two types of assessments used in different modules by different lecturers. Refer to each Student Learner Guide for the type of assessment for individual modules. These assessments are:

(i) Examination

This type of assessment is done at the end of the year where students are expected to write an examination. The duration of this differs from one module to the other. Refer to the Student's Learner Guide for individual modules.

(ii) Continuous assessment

This type of assessment occurs throughout the year where students are assessed through assignments, tests, etc. in different modules. There is no written examination at the end of the year for such modules. Refer to the Student Learner Guides for more details.

Continuous Assessment is applicable to all modules. There are no final summative examinations;

The pass mark for all modules is 50%.

A learner who does not perform to an acceptable level in an assessment is entitled to one (1) additional opportunity to improve his/her mark.

Re-Registration Rules (if more stringent than General Rules)

Refusal of Re-Registration

- A student who has been refused permission to re-register for a subject in terms of Rule G17 will not be permitted to register for any other subject in that qualification. A student will thereby be unable to complete the qualification.
- A full-time student who has not completed the Diploma within five years of the first registration may, at the discretion of the Departmental Appeals Committee, be refused permission to re-register, or may be accepted subject to special conditions.
- A student who wishes to appeal to the Faculty Board of the Faculty of Arts and Design against the application of rule above must submit to the Faculty Officer a statement in which she/he explains the reasons for this appeal. The appeal must be submitted to the Faculty Officer within ten working days of the student being officially notified in writing that she/he has not been permitted to re-register. No appeal will be considered after this.

5. ADVANCED DIPLOMA IN LANGUAGE PRACTICE (ADLPRI) SAQA ID (115397)

1-year full-time, NQF Level 7 qualification, SAQA credits is 120

5.1 Purpose

The purpose of this qualification is to produce language practitioners who have an enhanced understanding of the language practice profession, the contexts in which it functions and the ethical principles that inform it. In the multi-lingual country like South Africa, there is a growing need for reflective and critical language practitioners, and the students of this advanced diploma will be able to hone their practical skills as well as deepen their theoretical understanding of the environment and practice of translation, interpreting, editing and language planning.

The merger of theory and practice in the proposed curriculum will enable graduates to be able to demonstrate competencies of general knowledge and intellectual abilities needed to succeed in the professional environment of language practice. The qualification also prepares students for postgraduate studies in the field of language studies.

5.2 Exit Level Outcomes

- Apply an increased range of techniques and procedures in translating and interpreting a variety of texts, using applicable theories.
- Critically reflect on the importance of language practice in a multilingual and multicultural society.
- Select and utilise technological equipment and applications to perform language practice functions.
- Display ethical and professional behaviour as a language practitioner.
- Apply a broader range of skills and theories in the language practice field.

5.5 Programme information and rules

Selection criteria for this programme

- Diploma in Language Practice or equivalent qualification.
- Relevant qualification with language practice/ programme languages (English, isiZulu, isiXhosa, Afrikaans, Portuguese, Mandarin, French, South African Sign Language) as majors at NQF level 6 or a foreign qualification that is equivalent to the Diploma in Language Practice as determined by SAQA.
- A student is required to get an aggregate of 60% at Diploma level (or first qualification) in order to apply for this programme. The candidates are ranked according to the aggregate obtained at Diploma level and the target number of students are selected in order of merit.

6. POSTGRADUATE DIPLOMA IN LANGUAGE PRACTICE (ADLPRI) SAQA ID (118663)

1-year full-time, NQF Level 8 qualification, SAQA credits is 120

6.1 Purpose

The purpose of this qualification is to provide students with intellectual enrichment in the field by providing them with an advanced understanding of current thinking, theory and international trends in the field. Moreover, the qualification will provide articulation for students, who possess Postgraduate Diploma in Language Practice or cognate qualifications, with the opportunity to proceed Master's Degree.

The Postgraduate Diploma in Language Practice will provide students with intensive, focused and applied specialisation in the competency of translation, interpreting, research, business practice, human language terminology, terminology development and language planning and management. It equips students with the knowledge and skills required to broaden the scope of their function in the Language Practice environment, and further attempts to provide a holistic integrated approach to the student's broad range of competencies.

6.2 Exit Level Outcomes

- Apply advanced techniques and procedures in translating or interpreting a variety of texts, using applicable theories.
- Evaluate the importance of language practice in a multilingual and multicultural society.
- Utilise technological equipment and applications to perform advanced language practice functions.
- Acquire ethical and professional behaviour as a language practitioner.
- Utilise advanced theories and skills to plan and manage language matters in various contexts.

The Postgraduate Diploma in Language Practice graduates demonstrate evidence of several attributes. Students completing this programme will be:

- Critical and creative thinkers who work independently and collaboratively. These students will, by working as individuals and as team members, develop a variety of competencies and skills relevant to their Language Practitioner's work environment.
- Knowledgeable practitioners who will apply knowledge gained in language theory and practice.

6.5 Programme information and rules – Diploma language practice

Minimum requirements.

- **Advanced Diploma in Language Practice** or equivalent qualification (Advanced Diploma in Linguistics, Applied Linguistics or Language Studies).
- A relevant qualification with language practice/ programme languages as majors at NQF level 7, or
- A foreign qualification that is equivalent to the Advanced Diploma in Language Practice as determined by SAQA.

Specify the selection criteria for this programme.

A student is required get an aggregate of 65% at Advanced Diploma level (or first qualification) in order to apply for this programme. However, students may be admitted without the 60% aggregate if they have proof of at least 1-year relevant professional experience. The candidates are ranked according to the aggregate obtained at Advanced Diploma level, and the targeted number of students are selected in order of merit.

7. MASTER OF LANGUAGE PRACTICE (MSLPRI) SAQA ID (96835)

2/3-year part-time/ full-time, NQF Level 9 qualification, SAQA credits is 180

7.1 Purpose

THE HIGHER EDUCATION QUALIFICATIONS SUB-FRAMEWORK (HEQSF)

The National Qualifications Framework (NQF) is a system for the classification, registration and publication of articulated and quality assured national qualifications. The revised Higher Education Qualifications Sub-Framework (HEQSF), which was gazetted on 2 August 2013, forms part of this framework. The Faculty of Arts and Design is in the process of aligning all qualifications to the revised HEQSF.

WHAT DOES THIS MEAN?

Qualifications that are not aligned to the HEQSF will be phased out. New qualifications will replace the BTech and National Diploma. Some departments have opted to offer HEQSF-aligned Diploma qualifications, whilst others will offer Degrees.

The BTech, N Dip. and other qualifications that are not HEQSF-aligned will not be offered to first-time registering students from January 2020. Students who have registered for non-aligned qualifications before 31 December 2019 will need to complete that qualification before the final phase out date of that particular programme. Students who have already completed their National Diploma (NDip) and wish to register for the BTech have until 2019 to do so.

HOW DOES THIS AFFECT ME?

You need to ensure you complete your course before the final phase out date for the qualification you have registered for. As the BTech does not exist on the HEQSF, the Minister of Higher Education has gazetted 31 December 2019 as the final date for first-time entering students enrolling in academic programmes that are not aligned with the HEQSF. You will need to check the entry requirements and articulation pathways of your chosen course before applying.

WHAT EFFECT DOES THIS HAVE ON MY QUALIFICATIONS THAT WERE ON THE OLD NQF AND NOT ON THE HEQSF?

Your qualifications are still valid even though some of the current qualification types are not available on the HEQSF.

WHAT ARE MY OPTIONS?

For new (first-year, first-time) students registering, progression will be as follows:

- Diploma → Advanced Diploma → Postgraduate Diploma → Master's Degree → PhD/ Doctorate
Or
- Bachelor's Degree → Honours Degree → Master's Degree → PhD/ Doctorate

Please note: This is the general route of progression on the HEQSF. For specific information on what qualifications will be offered by particular academic programmes, please consult the relevant department.
