4. PROGRAMME INFORMATION AND RULES

The rules for the Bachelor of Journalism were approved by Senate on 13 November 2019. The rules for the Bachelor of Journalism Honours were approved by the Senate on 31st August 2022.

5. BACHELOR OF JOURNALISM (BJOURN), SAQA ID (111451)

This is a 3-year, 360-credit HEQSF level 7 Bachelor's degree

Purpose

The purpose of this qualification is to produce journalists who have an understanding of the Journalism profession and the ethical principles that inform it.

The graduates of this degree will be able to demonstrate competencies of general knowledge and intellectual ability as well as professional techniques of research, writing (and other forms of presentation), editing, design and production. The graduates would have achieved the ability to use the tools of journalism and to adapt to new technologies and innovative practices.

Exit Level Outcomes

At the exit level from this three-year programme, a student will be able to demonstrate the ability to:

- 1. Access, evaluate, use, and source information and language resources effectively and responsibly to create publishable stories and academic writing.
- 2. Produce and edit print media products by applying knowledge to news and feature genres, visual values, and ethics.
- 3. Produce and edit broadcast material applying knowledge to news genres, visual values, and ethics and
- 4. Be able to compile, edit and upload multimedia news and feature packages of a professional, publishable standard.

Graduate attributes

Critical and creative thinkers who work independently and collaboratively

Graduates will be capable of thinking contextually and applying logical, critical, and creative thinking strategies. They will have developed competencies that enable them to function effectively individually and within teams. They will be resourceful and responsible and able to manage relationships with other team members.

Knowledgeable practitioners

Graduates will have an in-depth knowledge of the journalism and media industry and of the societies and communities in which they exist, and an ability to apply that knowledge in practice.

Effective communicators

Graduates will demonstrate proficiency in communicating and presenting complex arguments and ideas effectively in oral and written forms and to diverse audiences.

Culturally, environmentally, and socially aware within a local and global context.

Graduates will have engaged in processes to enable them to recognise the seminal cultural, environmental, and social issues that have an impact both on their local context and globally. They will be aware of the ethical implications of human behaviour.

5.1 PROGRAMME STRUCTURE

The qualification is offered on a full-time basis only. The minimum completion time is three years, and the maximum time is five years (G21B). The programme is divided into six semesters or Study Levels I, 2, 3.

In addition to the General Rules of the DUT:

Students may choose from the available Institutional General Education and Faculty General Education modules according to the credit requirements of the programme.

The table below outlines how the modules in the qualification are structured.

Students must do all modules listed as compulsory and fundamental.

5.2 PROGRAMME RULES

Academic Integrity

Refer to the DUT General Rules pertaining to academic integrity GI3(I)(o) – covering falsification of academic records, plagiarism and cheating. These will be enforced wherever necessary to safeguard the worthiness of our qualifications, and the integrity of the Faculty of Arts and Design at DUT.

Assessment and Moderation

Continuous Assessment will be the method of assessment for all modules in the programme. As such, there are no final examinations, and there are no supplementary examinations. The results for all modules are determined through a weighted combination of assessments. Students are encouraged to work steadily throughout the academic semesters to achieve the highest results possible. Assessment details are outlined under Programme Rules. Assessments could include a variety of testing methods including, but not limited to, written tests, oral tests, practical submissions, group work, and assignments.

Minimum Requirements

On the basis of a variety of placement assessments, successful applicants for study towards the Bachelor of Journalism will be accepted into the programme. The General Rules applicable for admission into Bachelor studies will apply as per DUT Rules G3, G7, and G23B (1), In addition, the minimum entrance requirements are:

The minimum admission requirement is a National Senior Certificate (NSC) or National Vocational Certificate (NVC) as certified by the Council for General and Further Education and Training (Umalusi) with a minimum achievement of 5 for English Home Language and 6 for English First Additional Language. An additional requirement is an achievement rating of 4 (50 - 59 %) or better in four recognised NSC 20 credit subjects or equivalent. These requirements will be considered in tandem with any other university requirements.

Applicants, aged 23 and above, will be considered via the mature age exemption route. Applicants have to sit for a selection test, and, if successful, attend an interview, dates of which are pre-determined by DUT Journalism.

The onus is on applicants who are in secondary education to provide DUT Journalism with pre-matric (trials) marks at the time of their selection test (or soon thereafter) as well as to ensure that the first official print-out of their Senior Certificate or matriculation marks is sent to DUT Journalism. If selected, applicants are required to hand in their matric certificates

upon enrolment. Post-matric applicants are obliged to make their certificates and/or official printouts of post-matric marks available at the time of the selection test. Applicants must understand that admission can only be considered if a place is available. DUT Journalism has the discretion of whether or not to offer an applicant a seat in the degree. These Rules are with effect from 13 November 2019.

Exclusion Rules

In addition to DUT Rule G17, in Semester 1 student who fails three or more modules with a final result of less than 40%, is not permitted to reregister in this programme. Deregistration from any modules is according to the provision of DUT Rule G6.

Promotion to a Higher Level/Progression rules

The DUT Rule G16 applies. In addition to Rule G16, a student must pass all modules in Study Period 1 and Study Period 2 **BEFORE** being permitted to register for any modules in Study Period 3 (Senate approved November 2022).

Interruption of Studies

In accordance with Rule G21B, the minimum duration for this programme will be three years and the maximum duration will be five years of registered study. Should a student interrupt their studies by more than three (3) years, the student will need to apply to the department for permission to re-register and will need to prove currency of appropriate knowledge prior to being given permission to continue with registration.

Copyright

Copyright laws must be observed at all times. Refer to the Study Guides and the General Handbook for Students.

Refusal of Re-Registration

(i) A student who has not successfully completed any module after two periods of registration shall only be permitted to register for that module at the discretion of the Faculty Board Exco.
(ii) A student who has been refused permission to re-register for a module in terms of Rule G17 will not be permitted to register for any other module in that qualification. A student will thereby be unable to complete the qualification.

(iii) A full-time student who has not completed the National Diploma/Bachelor's degree within five years of the first registration may, at the discretion of the Departmental Appeals Committee, be refused permission to re-register, or may be accepted subject to special conditions.

(iv) A student who wishes to appeal to the Faculty of Arts Board against the application of rule above must submit to the Faculty Officer a statement in which she/he explains the reasons for this appeal. The appeal must be submitted to the Faculty Officer within ten working days of the student being officially notified in writing that she/he has not been permitted to reregister.

No appeal will be considered after this.

Exclusion Rules

In addition to DUT Rule G17, a Semester 1 student who fails three or more modules with a final result of less than 40%, is not permitted to reregister in this programme. Deregistration from any modules is according to the provision of DUT Rule G6.

5.3 PROGRAMMES INFORMATION

Continuous assessment

(a) Continuous Assessment is applicable to all modules.
(b) The pass mark for each module is 50%.
Feedback to students on assessment:
Written feedback to each student
Verbal feedback in consultation with each student
Verbal feedback to class

Work done during the year/semester Attendance

Attendance is compulsory. A student who, for any valid reason, is absent from planned academic activity must provide written proof of the reason for the absence to the lecturer concerned, within five (5) working days of returning to the institution in order to be considered for a special assessment. In these cases, the department will determine the validity of the student's reason for not taking the assessment and the nature of the special assessment. Refusal to accept this will result in a zero mark for the missed practical or test. As is the case with continuous assessment, i.e., 100% coursework, and no final examination, any student failing to obtain a final result of at least 50% will have to repeat that module.

Students are expected to attend all planned academic activities as these are designed to provide optimal support for the required competency. Students are expected to be punctual for all academic activities. Penalties may be applied for late or poor attendance (refer to Study Guide).

In addition to DUT and FACULTY Rules, the following PROGRAMME Rules shall Apply:

All assessment tasks will be described in the assignment/project brief at the commencement of the task. The brief will explain the duration, submission specifications, learning content and outcomes of the task, and will be accompanied by a marking rubric explaining how the task will be assessed.

All work submitted timeously for assessment will be marked, moderated and returned to the student within 10 working days of submission. Late submissions for some modules may be penalised (refer to Study Guide). Failure to write a test at the scheduled date and time will result in a zero being awarded unless a valid medical certificate is presented. This zero mark will be included when calculating the final result.

Any student failing an assignment/project with a mark of 45% - 49% inclusive will be permitted to resubmit their work within one week of it being returned to them. The revised mark will be capped at 50%. This rule does not apply to theory tests.

Feedback may be in the form of a consultation session (for theory and/or practical work); individual/group critique (depending on the type of assessment), or written/individual feedback (for written assignments), through marking memos or assessment rubrics.

Absentee notes must be submitted to the Programme Secretary within five days after the student's return. Notes submitted after this period will not be accepted. An extension of deadline may be granted by the lecturer only if it benefits the entire class group and if it does not extend beyond the semester.

For practical modules, all assessments and/or portfolio submissions may/may not be equally weighted and averaged (refer to Study Guide). For theory modules, all assessments will be equally weighted and averaged. General Education modules, offered by other departments or programmes, will be assessed and examined as described in the relevant Study Guide.

General Education Modules

Students must comply with the University's General Education requirements. This includes the following standalone General Education modules, which comprise:

Compulsory DUT Cornerstone 101 module.

Compulsory Faculty General Education module.

Elective Institutional General Education modules (Students will select electives modules as indicated in the Programme Structure).

In addition to DUT and FACULTY Rules, the following PROGRAMME Rules shall Apply:

(I) A student is required to attend all lectures and other pre-arranged forums -exceptions apply in a case of illness for which a valid medical certificate is to be supplied specifying the nature and the duration of the illness, or a sworn affidavit, or circumstances which in the opinion of the department were beyond his/her control at the time.

(ii) A student is required to attend all practical sessions and tutorials -exceptions apply in a case of illness for which a valid medical certificate is supplied specifying the nature and the duration of the illness, or a sworn affidavit, or circumstances which in the opinion of the department were beyond his/her control at the time.

Year Mark

(i) The year mark of modules assessed through continuous assessment, is based on the assessment method applicable to each module.

(ii) Students are given sufficient opportunity to accumulate a year mark. The number of assessments in each module as determined by the lecturer will be indicated to students.

(iii)A student must sit for all tests and submit all assignments by the deadline date in each module in order to be assessed.

Code of Conduct

In addition to the Student Code of Conduct in the DUT General Handbook for Students, and the relevant requirements as stated in the appropriate Study Guides, strict adherence to instructions issued by a technical, laboratory, or academic staff is required due to the need to ensure effective and safe practice in these facilities. A professional code of conduct pertaining to behaviour, appearance, personal hygiene, and dress shall apply to all students registered with the Faculty of Arts and Design, at all times.

Health and Safety

Students must adhere to all Health and Safety regulations. Failure to do so will be treated as a breach of discipline.

FEES

A breakdown of fees may be obtained from the Finance Department.

5.4 MODULE CONTENT

Semester I

Print Journalism IA - 8 credits (PRJO101)

Duration: 32 weeks theory: 2 lectures per week.

Assessment: Continuous Assessment

Syllabus: Print Journalism is a fundamental module in this programme. It equips journalism students with the understanding of print journalism and the tools and skills to work as print journalists for newspapers and magazines. This module also lays the foundation for writing for other news mediums.

Photojournalism IA - 8 credits (PHJO101)

Duration: 32 weeks theory: 2 lectures per week.

Assessment: Continuous Assessment

Syllabus: This module provides the foundation upon which other forms of visual journalism such as television and digital journalism are built. It helps instil in the journalism student a critical awareness of one's surroundings, which is a key attribute of a journalist.

Media Studies IA - 16 credits (MEST101)

Duration: 32 weeks theory: 4 lectures per week.

Assessment: Continuous Assessment

Syllabus: This module provides a historical and theoretical foundation upon which the other modules are built.

Court Reporting - 16 credits (CORE101)

Duration: 32 weeks theory: 4 lectures per week.

Assessment: Continuous Assessment

Syllabus: It trains the students in accuracy, ethics, fairness, and balance, the fundamental values of journalism.

Faculty Gen Ed Modules (compulsory) – Cornerstone 101 & English for the Arts Cornerstone 101 (CSTN101) - 12 credits

Syllabus: The module content will be developed around the concept of journeys, across time, across space, and across human relationships. It will take the journey of the uMngeni River (which is close to all DUT campuses) as a metaphor. The module will bring different disciplinary perspectives to this content – environmental, historical, and sociological in particular. The metaphor of the journey will be sustained across the module and will be applied to personal journeys, historical, political, and environmental journeys, and social journeys, with a specific focus on gender. Each section will draw on issues of ethics, diversity, and critical citizenry. The design team may later take a different metaphor or theme, but with the same outcomes and attributes.

The final section of the module will identify and integrate learning from earlier sections and examine implications for further learning. At each stage of the module, activities such as the weekly online journal and class discussion will involve reflection and building communicative practices. There will be a concluding section in which students will identify their learning and examine the implications for their roles as students and as citizens.

English for the Arts - 12 credits (EGLA101)

Duration: One semester

Assessment: Continuous Assessment
